

# WE NEED YOU!

## MONASH COUNCIL IGNORES YOU, BUT GRABS CASH.

In secret, on December 15, Monash Councillors resolved to accept \$21 million from the State Government and in principle commit **\$5.77m of Monash funds** to a new tennis centre, that was never previously planned. There was **no business case** to support this transaction.

### WHY?

North East Link stalled. The State Government was under pressure to find a location to replace Boroondara Tennis Center which will be removed for the NE Link/ Eastern Freeway Interchange.

4 Councils launched legal action over NE Link, Boroondara Council withdrew from the lawsuit in July 20, on agreed conditions, to find another site for the Boroondara Tennis Centre.

## ISSUES IGNORED.

The 4 Councils who launched legal proceedings against NE LINK (NELP); **Manningham, Banyule, Whitehorse & Boroondara**, cite NELP'S detrimental impact on residents; loss of 43,000 trees.

The key reason these Councils began legal proceedings against NELP was that the Planning Minister, Richard Wynne, ignored the recommendations and concerns of the Inquiry and Advisory Committee (IAC).

### Issues ignored include:

- 1 Major environmental impacts and loss of amenity.
- 2 Lack of local liveability and environmental analyses.
- 3 No provision for community engagement to discuss impacts.

## NO BUSINESS CASE.

**WAS COUNCIL PRESSURED OR COMPLICIT IN FIXING THE STATE GOVT'S PROBLEM?**

Although Monash has consistently underfunded infrastructure, there has not been a business case created for a large regional tennis centre, especially one that will disadvantage many local stakeholders.

**THIS LOCATION LACKS APPROPRIATE PUBLIC TRANSPORT AND INSTEAD DEMANDS MORE CAR PARKING.**

The re-elected Glen Waverley Ward Councillor stated you can trust him to share your priorities - by protecting our neighbourhood from inappropriate development and improving green spaces. But he, with the support of the majority of Councillors, allowed the same planning and consultation deficits faced by Boroondara residents to be transferred to you, his constituents.
